

## WORK ORDER FOR WATERPROOFING OF ROOFTOP (JUNIOR SCHOOL)

1. Reference is made to your tender bids dated 25 Apr 2023 with regard to the subject work. This is to inform you that the said work has been awarded to your firm. The work is to be completed within 90 days.

### 2. Terms & Conditions

(a) If the work is not completed within the stipulated period of 90 days (i.e. by 24 Aug 2023), a penalty of Rs. 500/- per day will be levied.

(b) A Project Management Group has been formed to monitor the project till its completion. The contractor has to interact with the group members for quality assurance.

(c) The work is to be carried out as per the BoQ enclosed as Annexure 'A'. If there are any defects, deficiencies noticed after the completion of the work within the warranty period (05 years) of the work, the same will be rectified by the contractor to the schools' satisfaction.

(d) Performance Guarantee by way of Bank Guarantee through a public sector bank or a private bank or a private sector bank authorized to conduct government business (ICICI Bank Ltd., Axis Bank Ltd., HDFC Bank Ltd., etc.) for a sum equal to 03% of the work order value has to be submitted within 07 days of receipt of the confirm work order. Performance Bank Guarantee should be valid up to 60 days beyond the date of the warranty. The specimen of PBG is given in **Form DPM-15** (Available in MoD website and can be provided on request).

(e) 4% (or as applicable from time to time) deduction of ESIC contribution on Labor Charges will be levied on payment to the vendors who are non-compliant with ESIC. Further, all applicable taxes will be borne by the contractor.

(f) Transporting / disposal of surplus malba from the site of work to the nearest dump is to be carried out by the contractor. Proper cleaning should be done after the completion of the project.

(g) AFBBS reserves the right to modify the conditions of the tender, at any time, without assigning any reasons for the same.

(h) Any additional work if required can only be done with the written approval of the school authorities.

(i) Good and standard quality of material as per BoQ must be used strictly.


(k) No escalation shall be allowed during the contract period.

(l) Sub-letting of contract is not allowed.

(m) In case of any damage to the school building/area due to the above-said work, the damage has to be rectified by the contractor. All school furniture/fixtures at the site should be take care of properly.

(n) The payment would be released as per the tender terms & conditions. Retention/Security money will be released after the warranty period of completion of work.

3. You are requested to start the work immediately and complete it in given time. The bill may be sent to School for releasing of the payment. **All necessary safety precautions are to be adopted during the execution of work. The contractor will be solely responsible for any mishap/injury related to the work service.**


