Sir,

This has reference to the tender submitted by you for carrying out the subject work. The technical bid of the said tender was opened on 26.09.2022 and price bid was opened on 23.11.2022.

In this regard, work order is issued to you for taking up the subject work at your total quoted amount of Rs. 15,56,000/- plus GST on the terms and conditions as provided in the tender document.

1. You are requested to attend this office immediately to execute agreement with non-judicial stamp paper of Rs. 100/-.
2. You are requested to deposit an amount of Rs 46,680/- (being 3% of the quoted amount) through NEFT/RTGS as per account details mentioned in the tender document or Demand Draft/Pay Order/Bankers Cheque drawn in favour of "The National Small Industries Corporation Ltd." payable at New Delhi towards performance security as mentioned at clause-8 of General Conditions of Contract (GCC) of tender document, within 10 days from the date of issue of this award letter. In addition to performance security, security deposit @ 5% as mentioned at clause 9 of the GCC of tender document shall be deducted from each running bill till the overall security deposit reached five percent (5%) of the accepted tender cost/ awarded cost.
3. The stipulated completion period of the subject work is 90 days reckoning of which start from 10<sup>th</sup> day of issue of work order or handing over of site whichever is earlier. In case the work is not completed within the stipulated completion period of 90 days, you shall be liable to pay Liquidated Damages @ 0.5% (one half of one percent only) of the value of contract per week and or part thereof of the delay subject to maximum 10% (ten percent only) of the value of contract.
4. Please note that the rates quoted by you shall remain firm even during the extended period if any, and no claim shall be entertained for extra payment due to any reason whatsoever even during the extended period.
5. As mentioned in the tender document, water proofing work shall be carried out over the roof top of the Main workshop and Advance training Institute Buildings of the NTSC-Okhla and hence utmost care has to be taken by the contractor to ensure that all the safety measures are adopted during working at site. Also, you will take necessary insurance covers in respect of the workmen engaged by you for carrying out the work and shall submit a copy of the same to NSIC.
